The ADHE Series 18-1: Tuition and Fee Charges must be submitted to ADHE by **June 15** preceding the start of the fall semester. For purposes of reporting tuition, SREB defines full-time as **15 credit hours** for undergraduate and **12 credit hours** for graduate per semester.

Mandatory fees, as defined by SREB, are those fees assessed upon enrollment to full-time undergraduate or graduate students regardless of student level or curriculum. For example, fees charged only to students in music, lab, or nursing OR only in given situations such as late registration and parking permits **should NOT be reported** as mandatory fees. Like reporting tuition, the definition of a full-time student is 15 hours for undergraduate and 12 hours for graduate.

Under **Special Notes** on **Page 2**, document any unique circumstances such as tuition has increased due to a removal of tuition or fee cap. Also, if fee(s) are included as part of the tuition rate, indicate this in Special Notes. **Attachments may be included to clarify any special issues.**
